2. **Documents Required.**
- One photo copy of educational qualification certificates duly attested by the competent authority.
  - One photo copy of matriculation certificate duly attested by the competent authority to verify date of birth (age).
  - A recent passport size photograph affixed on the application form duly attested by the competent authority.
  - One self addressed envelope with postal stamp of Rs. 25/- (Rupees twenty-five only).
  - One photo copy of caste certificate duly attested by the competent authority.
  - Name of the post should be mentioned on the top of the envelope.
  - Identification proof.
3. OBC and Ex-Servicemen candidates who apply against unreserved post are not entitled for age and other concessions meant for them.
4. **Nature of test.** A written test will be conducted on the following field to test the ability of the candidates :-
- General Intelligence & Reasoning
  - Numerical Aptitude
  - General English
  - General Awareness
5. **Date of Practical.** Written exam and practical/physical or skill test:-
- Will be intimated to eligible candidates individually. No TA/DA will be admissible to the candidates for appearing in the recruitment test.
  - If large number of applications are received for the posts, the Commandant 14 GTC Subathu reserves the right to restrict the number of application for the post by fixing a cut off percentage of marks obtained in required minimum qualification or any other criteria.
  - The Commandant 14 GTC Subathu reserves the right to short list the applicants on the basis of available vacancy and the number of eligible applicants.
6. **Probation.** Candidate selected will remain on probation for a period of 02 years.
7. **Location of test.** 14 Gorkha Training Centre Subathu (Shimla Hills).
8. Merely fulfilling the basis selection criteria does not automatically entitle a person to call for the trade test. No extra weightage will be given for the additional/extra/higher qualification in recruitment.
9. On completion of the written test qualifying candidates will be called for the practical/physical or skill test.
10. Unsigned/incomplete application will be rejected.
11. If a candidate produce false certificates then he will be disqualified/dismissed from service, if appointed.

12. Candidates may apply for only category of reservation. In case candidate submit more than one application for the same post, the candidature is liable to be rejected.
13. Registration of application does not guarantee the employment.
