Manpower-Vol.V/2023-6059-6063 dated 15.01.2024 and further conveyed vide superintending Engineer Jal Shakti Circle Hamirpur office letter No. JSV-HMR-SE-ES-EA-II-E-Para Worker/2024-11409-12 dated 19.01.2024 applications are hereby invited from eligible candidates for the following posts on honorarium basis (Six hourly per day) for departmental schemes in accordance with the para worker policy of the department after removing the service of workers engaged through contractor against outposting WSS/LIS/FIS in Jal Shakti Division, Bhoranj. The applications on prescribed format should reach in the office of the Engineer-in-Chief, JSV, Shimla, Himachal Pradesh, India on or before 31.01.2024. Applications received after due date or found incomplete will be rejected straightway without assigning any reason. The department will not be responsible for delay in receipt of applications due to any reasons whatsoever.

Para Pump Operator	11	6000/-Pm	The candidate should have a minimum qualification of Matriculation (10th) with ITI Certificate in the trade of Electrician/ Wireman/ Diesel Mechanic/ Pump Mechanic/Motor Mechanic/Pump Operator-cum-Mechanic/ Mechanic (Motor Vehicle)/Pump Operation & Maintenance from a recognized ITI or Matriculation (10th) with certificate in above cited trade under Skill Development Scheme of the Government.
2.	Para Fitter	4	6000/-PM	The candidate should have a minimum qualification of matriculation (10th) with ITI Certificate in the trade of Fitter/Plumber from a recognized ITI/ Institute or Matriculation (10th) with certificate in above cited trade under Skill Development Scheme of the Government.
3.	Multi Purpose Workers	25	4400/- PM	The Candidate should have a minimum qualification of Middle (8th) pass or its equivalent from School duly recognized by the State Government.

Age limit: - 18 to 45 years as on 31.01.2024.

The number of Posts may increase or decrease depending upon Vacancy position on the last date of Skill/Physical Test.

Documents to be attached with application forms:

Attested/Self attested copies of (i) Legitimate proof of age (ii) Proof of BPL family in case of BPL candidate issued not later than six months (iii) Proof of Education and Technical qualification (iv) Certificate of Bonafide of Himachal (v) Certificate and experience (if any) of the related field of JSV/HPPWD/CPWD/PSUs issued by the competent authority OR Outsourcing agency providing services in HP Jal Shakti Vibhag.

General Instructions:

1. It shall be the responsibility of the candidates to submit all requisite documents mentioned above as short listing/eligibility shall be done in case the application received are much more than the numbers of post.
2. The short listing/eligibility will be based upon the documents submitted and the shortlisted candidates will have to undergo a skill / Physical Test.
3. If a candidate wants to apply for more than one post, separate application for each post needs to be submitted.
4. Applications received after due date shall be rejected summarily without assigning any reason.
5. The Candidate will be called for Skill/ Physical test separately.
6. The original certificates/testimonials will be seen at the time of evaluation.

Note:- Candidate applying for Multipurpose workers shall compulsory attach detailed marks sheet of middle standard and in the event of non issuing of the same by the concerned Education Board the detailed marks certificate from the Principal of the school needs to be attached. Evaluation criteria and short listing (if necessary) is based upon marks obtained in the Middle standard and not of any other standard even if higher qualification is obtained.
