

## HIMACHAL PRADESH JAL SHAKTI VIBHAG "EMPLOYMENT NOTICE"

**Note:-** Candidate applying for the post of Para Pump Operator, Para Fitter shall compulsory attach detail marks sheet of matriculation and Multipurpose Workers shall compulsory attach detail marks sheet of middle standard and in the event of non issuance of the same by the concerned Education Board, the detail marks certificate of Principal of School needs to be attached for evaluation criteria and short listing . Application received in this office without detail of marks will be rejected.

**Age Limit:-** The age limit for applicant shall be between 18 years to 45 years and knowledge of custom, manners and dialects of Himachal Pradesh is desirable.
